3. Bidding documents may be purchased by eligible bidders from the EGP portable of PPMO www.bolpatra.gov.np upon by submitting bank receipt non-refundable fee of NRs.3000 (In Words: Three Thousand Rupees Only).
4. Interested Bidders shall submit the electronic Bids through www.bolpatra.gov.np/egp to the above office of Office of the Attorney General, Nepal, Ramshahpath, Kathmandu on or before 12:00 Hours, 2078-11-10.
5. Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the following Rajaswa (revenue) account as specified below.

6. Sealed Bid (Hard Copy) must be submitted within 7 days from the opening of the bid to above offices. Documents received after this deadline shall not be accepted.
7. Bids shall be opened in the presence of Bidders' representatives who choose to attend at 14:00PM, 2078-11-10 at the office of Office of the Attorney General, Nepal, Ramshahpath, Kathmandu. Bids must be valid for a period of **120 days** from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs.445,000 (In Words: Four Lakh Forty Five Rupees Only)**, which shall be **valid for minimum 30 days** beyond the validity period of the bid.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
9. The Purchaser reserves the right to amend or correct and accept or reject, wholly or partly, any or all the bids without assigning any reasons, whatsoever.
