Content

- Font Times New Roman
- Font size 12 pts.
- Line spacing 1.5
- Margin 1" from all sides

• Alignment: Justified

Footnotes

- Font Times New Roman
- Font size 10 pts
- Line Spacing 1.5
- All the sources in the footnotes must be properly cited strictly in accordance with the latest OSCOLAformat.(Link: <u>https://www.law.ox.ac.uk/sites/files/oxlaw/oscola 4th edn hart 2012quickreferenceguide.</u> pdf)

General Instructions

- Co-Authorship to a maximum of two members is allowed.
- An abstract of about 250-300 words and 5 keywords should be mandatorily included in the same word document as a part of the submission.
- The title should be Bold, Underlined, in Capitals, Size 16, and Centre Aligned.
- Headings should be Bold, in Capitals, Size 14, and left aligned.
- The contents should, in no way, directly or indirectly, indicate or reference the identity of the author(s).
- The submission should be original and non-plagiarized. Submission of a paper shall be taken to imply that it is an unpublished work and is not being considered for publication elsewhere.
- The author(s) must send in cover letter in the body of the mail, which must contain all relevant biographical details (Name of the author(s), their professional engagement, Designation, Address, Phone Number and Email ID).
- The mail consisting of the manuscript must indicate category that the submission is intended for, i.e. Article/ Essay/ Case Comment/ Book Review.
- Editors reserve the sole rights of publication of the selected articles in addition to; inter alia, any edits/amends/reproduction.
- The contributions presented to and accepted for publication and copyrights therein shall be the intellectual property of the Editorial Committee, Office of the Attorney General Nepal.

How to Submit

The submissions may be emailed to the given contact details in Microsoft Word (.doc or .docx) format. The attached submission in the email, i.e., the name of the document must be the name(s) of the author(s). The subject title for the mail must be 'Article/Essay/Case Comment/Book Review for Volume5'. Please note that only one submission per author or a team of co-authors is permissible. In case of more than one submission, consultation with editorial team is required.

Submission Deadline and Review

The manuscript must be submitted by August 15, 2021. A robust peer review procedure shall be implemented. This would result in a higher standard of evaluation and recognition of high-quality academic work.
