## Australia Awards Scholarships Information Seminar for Government of Nepal Officials

Dear Mr Lamsal

I am pleased to inform you that applications for Australia Awards Scholarships for study commencing in 2023 are now open and will close on 29 April 2022. Australia is pleased to continue its support to long term capacity development in Nepal through Australia Awards. Over the last 60 years, more than 1,100 Nepalese have benefited from Australia Awards Scholarships, Fellowships and Short Course opportunities.

I would like to take this opportunity to thank the Ministry of Foreign Affairs (MOFA) for the support provided in different stages of the Australia Awards cycle. In July 2021, for example, MOFA's Mr Krishna Chandra Aryal represented Government of Nepal in the Australia Awards Selection Interview Panel for Scholarships commencing in 2022. I am pleased to inform you that the panel nominated 20 applicants, including 11 public service officials, as successful candidates. They will commence their study in June 2022 along with 10 other nominated applicants from previous two selection rounds, subject to Australia's border requirements.

There are eight priority sectors identified for this round of application: Disaster Risk Reduction; Economic Development, Education; Gender Equality, Disability and Social Inclusion; Governance; Health; Natural Resource Management and Sustainable Infrastructure Development. These priority sectors are built on Nepal's development priorities as outlined in its periodic plan.

Consistent with our commitment to inclusion, women, people with disability and people from traditionally marginalised groups are encouraged to apply. All candidates will undergo a merit-based selection process.

To provide the prospective applicants with relevant information, the Australia Awards team is organising online information sessions. A separate online session is being organised exclusively for civil service officials at the Ministry of Federal Affairs and General Administration (MoFAGA) on 25 February 2022. Interested officials can register for the session through the Australia Awards website: <a href="https://australiaawardsnepal.org">https://australiaawardsnepal.org</a>.
